<b>System</b>	GranoPearl® Bold Impact
<b>Substrate</b>	Exterior – New and uncoated off form concrete

## Product Features

GranoPearl® is a high-build, texture coating system, rolled on to give a bold texture or flattened by a plastic triangle then topcoated with GranoImpact® (G2.01) or GranoSkin® Membrane (G2.14).

## Surface Preparation

Ensure all new cementitious substrates are fully cured prior to painting. Typically this may take a minimum of 4-6 weeks. There must be less than 15% moisture content in the surface at the time of application to ensure optimum coating performance. The surface must not be subject to frequent wetting or hydrostatic pressure. Any foreign material that may affect adhesion must be removed prior to coating. Grind off any protruding formwork joints.

**Patching or Skimming Imperfections:** Examine surfaces closely for air holes and imperfections, patch or skim as required with GranoPatch® Smooth (G1.04) or GranoPatch® Spackle (G1.05). Block down, allow to dry, sand back and dust off.

**Rendering:** Apply GranoBond® (G1.01) keycoat system liberally (0.5L/m<sup>2</sup>) to surface and allow to dry for 24 hours. Render surface with the appropriate GranoRender. Allow to cure 7 days.

**Priming:** Off form concrete with a very hard or smooth surface must be primed with GranoPrime S (G1.03).
